Annual General Meeting

Committee Remains Unchanged

here was a tense moment at 7:30 when the AGM was due to begin. The residents eyes were fixed on the Committee, and the committee's eyes were fixed on the door waiting for one more resident to enter and complete the quorum needed for the meeting to begin. And then at 7:35 this 21st century Godot finally made an appearance and the meeting got underway.

Thirty-one residents were present and 25 proxies were received. There were also a small number of apologies. The committee reports, delivered to homeowners before the meeting, were referred to and then questions were called from the floor. Unusually, there were none, and so the meeting proceeded to the next item on the agenda, the Election of Officers.

There were two committee positions which needed to be filled, the Secretary and the member for Parks and Reticulation. Sandra Wilson renominated for the position of Secretary, and being the only nominee, was duly elected. Rob Wilson, the current member for Parks and Reticulation, received a nomination from the floor, and surprisingly, accepted. He, too, was, gratefully elected. The position of Social Club Coordinator, vacant since the resignation of Sue Galpin for family reasons almost six months ago, remains unfilled. It was emphasised how important this position is as many residents come to Crestwood for its sense of community.

Before moving on to General Business, the Treasurer, Roy Malone, made a point of thanking our auditor, Michael Lee, for his help and dedication to the job. He has served as Crestwood's auditor in an honorary capacity for over 30 years.

The first item of General Business was the introduction of our new gardeners, Graeme Singleton (full-time) and Grant Douglas (part-time). They were not present at the meeting, simply introduced, and their working hours outlined to the meeting.

The second item of general business was the Crestwood News. On behalf of the editor, the President, Trevor Davis, mentioned that it was becoming increasingly difficult to fill a 16 page newsletter six times a year as there was a dearth of contributions from the residents. The option was to move to a 12 page newsletter which would include the necessary reports, announcements, contacts and advertisements, but would exclude the feature sections unless there was room for these extras. Feedback which had been informally received has indicated that residents are happy with the current format, and so those at the meeting were encouraged to contribute items, or mention to their friends and neighbours on the estate that contributions were needed.

The meeting was then opened to the floor. The first item raised related to a Chinese peppercorn tree in the Crestwood park behind Cavalier Court, easy to climb and sometimes climbed by as many as 14 children at a time. The issue was not only about the noise and the swearing, but also about security. There was one instance where those in the tree seemed to

serve as lookouts for another who entered the rear of a property, presumably looking for something to steal. Options raised for dealing with the problem were removal of the tree (unlikely since it is liked by at least one other neighbour), cutting off the lower limbs thereby making it harder to climb (also unlikely considering the nature of the tree) and erecting a physical barrier so it would not be possible to climb. The various options are to be investigated further.

On the topic of trees, another matter was raised regarding removal of trees on one's property. If these are not native Australian trees, they can be removed without permission of the Committee. If they are native, then permission is required. This is usually given if the trees are causing some damage, for example, lifting footpaths, pushing over fences or otherwise interfering with buildings.

The next item that was raised from the floor was an extension of the footpath which runs along Spencer Road so that it extends further into Regency Drive. At the moment the footpath on one side curves somewhat into Regency Drive, and on the other side ends at the intersection. An extension would allow pedestrians, including those pushing prams and strollers, to access the footpath before actually entering the intersection via the road. The footpath should be extended on both sides of the intersection. It was also suggested that a street light was needed at the end of the service road. Since the City of Gosnells was looking at path repairs in our parks, it was suggested that they might also have a look at

The reticulation also came up for mention. This season just ended has been very successful with few breakdowns, and so the questions asked and information provided dealt with future plans and maintenance. Work on the mainline is to begin during the second or third week in June and during this maintenance period, which will go on for about a month, the fortnightly Sunday tests will be suspended. Questions were also asked about the scheduled service intervals for our five bores, and who would carry out work in the event of a breakdown. Regarding servicing, the gardeners would carry out minor repairs, and call in Total Eden if there were major problems to be seen to.

Staying on the question of water, it was suggested from

the floor that Crestwood put in a request to increase our water allocation, even if this was not needed and unlikely to be needed in the near future. The reasoning behind this request was to increase Crestwood's bargaining position in the event of our water allocation being cut in the future. Any cut would then apply to a greater base allocation.

The state of Crestwood's parks also came in for positive comment, with one resident saying he could not remember them looking so good. Credit went to Rob Wilson, the member for Parks and Reticulation, and to Ryan, who unfortunately, has left Crestwood. The park lights were also discussed: the replacement of rusted ones, the timing of their operation and the suggestion that they all be put on sensors. A decision on the installation of sensors could only be made once a prior decision was made on whether to replace the old and deteriorating poles. One final note on the parks: Sandra Wilson, our secretary, has been able to contact the art coordinator at Thornlie Senior High School who has agreed to have their students redo the murals of the underpasses. This is to begin in 2010 and will replace the existing murals painted originally in 1995.

An interesting enquiry from the floor tied together elements of economics and aesthetics. With a rise in the electricity tariff, and the desire of some residents to contribute to a reduction of greenhouse gasses, there would inevitably an increase in homeowners who wished to install solar panels on the roof. The resident who raised the issue indicated that he did not believe that covering a roof with solar panels was aesthetically pleasing, and that the committee should look into developing guidelines before such installations become common.

Subsequent discussion focussed on the efficiency of generating electricity in this way and the number of panels that would be needed to achieve enough electricity for a family of two adults and two children. Considering that the efficiency of solar panels is said to be just 17%, 16 panels would be needed in such circumstances, more than would fit on the north-facing part on anyone's roof. The committee indicated that it would discuss that matter further, and that, in the interim, residents contemplating installing solar panels, first contact the committee member for aesthetics.

- □ A Free Home Safety Assessment The WA Police and the Fire and Emergency Services (FESA) will visit you in your home and make recommendations on ways to improve your home safety. A staff member from the City of Gosnells Seniors and Disability Services Branch will all also attend.
- □ **A Free Smoke Alarm** Subject to funding, a free smoke alarm will be installed on the recommendations of the professionals. Please remember, it is your responsibility to put in place any other recommendations made during the Home Safety Audit.

Who is Eligible for a Home Safety Audit?

To be eligible for a Home Safety Audit, you must:

- ☐ Live in your own home or a rental property.
- \square Be 55 years and over.
- ☐ Live within the City of Gosnells

OR

- ☐ Be a person with a disability or their carer.
- □ Live within the City of Gosnells.

What are your Responsibilities?

When you request a Home Safety Audit., you are responsible for:

- ☐ Deciding whether to implement any recommendations made during the Home Safety Audit.
- □ Payment for any of the recommendations made during the Home Safety Audit that you deicide to implement.
- ☐ Letting us know if the appointment can't be kept.

Don't get skimmed at the ATM

The recurrence of card skimming in Perth has highlighted the need to be careful with your PIN and vigilant when using ATMs.

The card skimming scam, usually run by organised groups, works by a scanning device being placed over the ATM card slot to record the card's magnetic strip as it enters the machine. The victim's PIN is then captured by a small camera in the corner of the machine. Within just a few days a copy of a card with a valid PIN can appear in Europe or elsewhere.

This scam usually requires the complex manufacture of a device that fits over the front of the ATM to look completely natural to the machine. There is, however, another version of the scam which can be surprisingly low tech.

In this version, an ATM is tampered with so that it does not work as it should. Someone then waits in the queue offering to help. If an ATM you are using does not work as expected, do not accept an offer of help from another person in the queue and don't hand over your card to anyone.

If you suspect an ATM is not working properly, take out extra cash when making an EFTPOS purchase at one of the shops you frequent, or at a bank.

Scooters: Thieves Love 'Em and Leave 'Em

Over the last five years in Australia, motorcycle theft increased by 34%. In that time, passenger/light commercial (PLC) vehicle theft decreased by 36%. Honda, Yamaha, Suzuki and Kawasaki continue to be the most popular motorcycle theft targets, however, since 2003, theft of these brands has decreased.

Analysis of the thefts showed that 85% of the models stolen were scooters. Additionally, of the top ten motorcycle brands that experienced an increase in theft from 2005 to 2008, more than half the models were scooters (57%). Two thirds of these scooters (64%) were recovered, which was double the recovery rate of all motorcycles (excluding scooters) (32%). These scooters, like other motorcycles, were commonly stolen on Friday and Saturday between 4pm and midnight.

According to the latest figures from the Federal Chamber of Automotive Industries, more than 15,000 scooters were sold in 2008, an 8% increase compared with 2007

The NMVTRC is working with the Australian Scooter Federation (ASF) to develop an information package for buyers and riders about how to minimise their theft risk. For tips on securing your motorcycle visit:

Committee Business:

Parks and Reticulation: Discussion was held regarding a policy for dealing with untidy or dangerous areas between fences at the back of properties and the park. This came about after a letter was received about the pruning of bougainvilleas outside one property. This particular case seems to have been due to an error of communication between the Com-



mittee and gardeners. A letter with regard to this is to be drafted by Sandra and circulated to Taffy and Ryan. Some of the quotes have now come in for work on the reticulation mainline, with one quote still to come. An attempt will be made to replace two sections of the line once the reticulation is turned off. A suggestion was made to have Taffy working here while the mainline replacement work is being done. Taffy is now working 20 hours a week.

Possible white ant activity has been noticed in the parks. A quote is to be obtained for the checking and treating of affected trees.

The gardeners will purchase a smaller hedge trimmer and replacement sprinklers.

Pool: The new window has now been installed, as well as the new vacuum cleaner. The YMCA has overcharged us on their invoice. This is to be queried and dealt with by Roy.

Finances: All accounts have now been distributed for the 2009-2010 Crestwood fees.

Workers compensation insurance falls due in June, with all other accounts due at the end of March. The current insurance cover and costs were outlined and discussion was held regarding the current value placed on buildings and the pool. It was decided to increase the value of these to \$2,000,000 and change the insurance cover to Allianz keeping the current excess and assuming the cost of the new insurance would be reasonable.

It was decided to add the trailer to the existing motor vehicle policy. It was also agreed to change the existing public liability policy currently with AIG Insurance (USA) to Chubb considering the current financial difficulties experienced by AIG.

Social: A new vacuum cleaner has been purchased for the Crestwood Hall. The sign in the hall reading "No Dogs Allowed" is to be changed to read "No Pets in the Hall/Pool Compound". A cleaner is still required for the Hall. A letter is needed regarding hirers taking all responsibility when in the toddler pool area.

General Business: Two committee positions come up for renewal — Parks and Reticulation and Secretary. Rob does not wish to be nominated for another term. Sandra is willing to continue as secretary.

Notice of the AGM will need to go out 30 days in advance of the meeting on 27 May, along with nominations and proxy forms and reports.

APRIL 2009

Committee Business:

Parks and Reticulation: Ryan has given notice of his resignation. An advertisement which was placed in the West Australian attracted many responses and applications have been received. Thanks to Trevor Davis for organising this.

Total Eden has been given the job of completing work on two sections of the reticulation mainline. Discussion was also held regarding insurance on park trees.

Two quotes were received for treatment of a number of the park trees affected by white ants. Treatment is to be done by Stewarts and Taffy is to organise this.

Aesthetics: Amendments have been made to letters regarding the strip of land between the back of properties and the park. These have been circulated to committee members and will be discussed before being used.

Pool: A meeting was held with the YMCA and the pros and cons of the season were discussed. As a result, changes are to be made with regard to staffing for next year.

Scanning for pipes at the surrounds of the pool is to happen after the pool's closure. A busy-bee is scheduled for the first Sunday in May to close down the pool with a flyer being sent out to residents. A skip is to be organised to get rid of unwanted rubbish.

Some items were thrown into the pool one evening. The gates to the pool were also left open and this was not discovered until Monday morning.

Finances: Our insurance cover has now been changed and we are awaiting a replacement statement with corrected values listed.

Social: A new coordinator is needed for this position. This will be added to the business at the AGM.

General Business: The security system in the office is in need of attention. Further study of the system is needed as well as the completion and installation of the supplied equipment.

A bereavement notice in to be placed in *The West Australian* on the death of Taffy's dad.

Visitor's Business: One of the visitors noted that the gardens were now looking particularly wonderful and asked about the situation regarding employment of the gardeners, particularly the need for a second gardener working part time. The answer to this was that two people are required to perform certain tasks to conform to the occupational health and safety guidelines. A second visitor expressed his concern at the gardeners situation, particularly with Ryan's resignation.



One of Crestwood's residents, Joshua Catalano of Coronet Court, was one of the contestants chosen to enter this contest. I had a chance to interview him for this issue of the *Crestwood News*.

The Background

Joshua heard about MasterChef Australia from a friend who saw an advertisement on TV. Applications were on-line and Joshua applied in early January. There were 7500 applications from all over Australia. This initial group was eventually reduced to 160 applicants who were then asked to attend the first day auditions.

The Selection

These first day auditions gave Channel 10 a chance to meet, evaluate and eventually choose those contestants who had an interest in food, had the potential to become a chef, and had the personality to appear on television. Each of these 160 contestants was asked to prepare a dish which they brought into a room with nine others. These 10 contestants were paired off, with each offering an assessment of the dish of their partner. At the same time, this interaction was examined and evaluated by assessors from Channel 10. Of these 160 people, 70 were eventually chosen, seven of them from Perth.

On the second day of the auditions, the remaining 70 contestants cooked for the three judges with each contestant having one hour to prepare a dish of their choice. The aim was to select 50 contestants from this group who would appear in the opening series on television. The dish Joshua chose to prepare was *duka* encrusted lamp chops - *duka* being an Egyptian mixture of nuts and middle-eastern spices. Although he is from seafood background - the son of the Catalano seafood family - he chose this meat dish to show his versatility.

Joshua was not only selected as one of the top 50 contestants, but was also chosen as one of the 20 contestants to compete in the show. This final number of contestants was housed together in Sydney. Although each contestant was potentially in competition with another, Joshua mentioned that most got along well, at least at first. They were all united by an interest in food and cooking and when someone in the house cooked, there was support and suggestions coming from the others. Not all, however, were so open and cooperative. There were some who were more secretive, choosing not to cook in the house. It became obvious as time went on that there were those who were there only to win.

The Long and Busy Days

The cameras and lights were an ever-present background to Joshua's stay in Sydney. These were long days, with 6 am starts and an 11 pm return home. There was a lot of filming, with 20 cameras shooting from various angles. Joshua indicated that this was probably the most difficult thing to deal with, always under bright lights, always expected to perform, and always pinned with a microphone to capture his words. Not all of it was exciting. There were a lot of retakes and accompanying this a lot of standing around and waiting.

The group was also in complete lockdown. There was no phone in the house and no internet. Contestants were allowed only one phone call a week, and the receipt of calls was limited to emergencies. Joshua mentioned that this isolation was not easy, particularly as he had responsibilities

at work and could not be reached if things went wrong.

The Elimination

The show used a process of peer elimination to gradually whittle down the numbers to arrive at the winner and MasterChef of the competition. This was not a process that Joshua particularly enjoyed. He would have preferred it if



the judges, three well-known and respected chefs, had been in charge of the elimination, and if the criteria was based solely on food. As it was, some of the peer decisions were based on friendships, and some, possibly, on eliminating a stronger competitor. Elimination was also not always based on cooking. It could also be based, for example, on the quality of leadership, reflecting how a leader performed in one of the group challenges.

The Judges

Joshua felt the judges were great. He and the others respected their opinion as experts and they were genuinely helpful with time even being given off-set. He was not upset by their comments and felt it was the same with the others. If they were upset with anyone it was themselves, since they knew they could do better.

The judges offered master classes as part of the show, and there was a lot for the contestants to learn. When Joshua was asked what was one of the most significant things he learned from these classes, he mentioned that it was how to joint a rabbit. And of course there was the chocolate mousse made with olive oil. That was seared even into the minds of the television viewers.

The Experience

Joshua indicated that this was his first time in such a situation. What he learned most was how to handle himself and how to cope under pressure. It was a daunting process being evaluated, serving food to the judges and learning how to deal with the feedback. He even had the opportunity to cook for Curtis Stone and Manu Feildel, as well as the chance to watch them cook.

What Joshua took away from this experience was not only an acquaintance with some well-known personalities, but also some new friends from the show who shared his love of cooking. Now that it is all over, he finds himself a little more famous than he was before. People recognise him from his appearance on TV, on the show website and from magazine articles. Some even sound their car horn and others stop him for an autograph or to ask for a photo.

The Conclusion

We can reveal now that Joshua made it to number 14 before being eliminated, a very commendable performance, particularly as this was a nation-wide competition. When the results of the voting became obvious, Josh said, "When you serve up a dish and you see people smile, the feeling you get inside is sometimes better than eating [the dish] and enjoying it yourself". This was a very generous statement to end his involvement in the competition.

I'm sure the Crestwood Community will join me in wishing him the best, not only for his future in cooking, but in his other enterprises as well.





Glacier Caves !!!

A glacier cave is a cave formed within the ice of a glacier. Glacier caves are often called ice caves, but this term is properly used to describe bedrock caves that contain year-round ice.

Most glacier caves are started by water running through or under the glacier. This water often originates on the glacier's surface through melting, entering the ice at a moulin and exiting at the glacier's snout at base level. Heat transfer from the water can cause sufficient melting to create an air-filled cavity, sometimes aided by solifluction. Air movement can then assist enlargement through melting in summer and sublimation in winter.

Some glacier caves are formed by geothermal heat from volcanic vents or hot springs beneath the ice. An extreme example is the Kverkfjoll glacier cave in the Vatnajokull glacier in Iceland, measured in the 1980s at 2.8 kilometres long with a vertical range of 525 metres.

Some glacier caves are relatively unstable due to melting and glacial motion, and are subject to localised or complete collapse, as well as elimination by glacial retreat. An example of the dynamic nature of glacier caves may be seen in the Paradise Ice Caves located on Mt. Rainier in the United States.

Known since the early 1900s, the caves were thought to have disappeared altogether in the mid 1940s, yet in 1978 cavers measured 13.25 km of passageways in glacier caves there, and it was considered the longest glacier cave system in the world. The Paradise Ice Caves collapsed and vanished in the 1990s, and the lower lobe of the glacier which once contained the caves also vanished entirely between 2004 and 2006.

Glacier caves may be used by glaciologists to study the interior of glaciers. The study of glacier caves themselves is sometimes called glaciospeleology.

Can you discover the meaning of the words in Malay? There are specific techniques you can use to do this. Two of the easiest are repetition and minimal difference. For repetition, you look at sentences in which just one word or phrase is repeated. For minimal difference, you look at sentences or phrases which differ in only one way. There is also word position and remainder. For word position, you look to see if a particular type of word always occurs in the same position in the sentence. (You look at the language you are trying to identify, not English!) And then there is remainder: the only word left in a phrase or sentence after the other words have been identified.

Nouns in Malay may be built up from verbs by adding prefixes (sounds added to the front of a word) or suffixes (sounds added to the back of a word). You will see this in the word for the noun *drink* where a suffix is added to verb *to drink*, *food* where a suffix is added to the verb *eating*, and *cook* (the person who cooks) is formed by a prefix added to the verb *cooking*.

There are a number of words which appear in English which do not appear in Malay. These are shown in brackets [] in the English translation. The preposition (at) appears in Malay but not English. Answers in the Next Issue of the Crestwood News.

Malay is an Austronesian language spoken in Malaysia, Brunei, Singapore and Indonesia. Historically it has been a trade language for the island and peninsula areas of Southeast Asia.
