Special General Meeting

Budget Approved Unanimously General Discussion Touches on Topics of Interest

The Special General Meeting got underway at 7:40, the later than scheduled start attributed to a final check to make sure that a quorum had been reached. The final count of 39 households present and 61 proxies put us 11 over the constitutional requirement and the meeting began.

This was not a contentious budget proposal, and with a motion that the current fees show an increase of only \$11.00 over last year's budget, it was not surprising that approval was fast and unanimous. The only question from the floor was in relation to the cost of electricity which was scheduled to rise substantially over the coming year. To cover the expected increase, the Treasurer indicated that he had budgeted for a 23% rise which he believed would cover any contingency. The formal part of the meeting was then closed at 7:48 setting what is perhaps a historical record.

As in the past, the President then asked if there were any topics that might be raised in a general discussion. The status of Crestwood's parks was brought up and this was clarified by the President. The parks are classified as public open space over which Crestwood holds a 99 year lease. The lease was renewed once when Cavalier Court was added to the estate to acknowledge the incorporation of additional land. The overall term of the lease remained the same. The City of Gosnells contributes to the parks' upkeep by giving Crestwood the equivalent of a Gosnells employee's salary, currently \$59,000 a year. The City also has been maintaining the concrete paths through the parks, although, officially, this was Crestwood's responsibility under the terms of the lease. This additional contribution on the part of the City Council was successfully negotiated several years ago by the Crestwood committee serving at the time.

Regarding water, our licence has been renewed for a further 10 years at the same level as in the past, that is 120,000 kilolitres a year, a level which, on best estimates, Crestwood has never reached. The question of having our bores metered is still on the agenda and metering will probably be required at some time in the future. The expense for doing this will be Crestwood's.

The discussion then turned to safety and security. As mentioned in the President's report in the previous edition of the *Crestwood News*, there is a 21 year-old who has been loitering on the Estate.

The President spoke to this person when he was seen loitering in the vicinity of the Crestwood Hall. He has been identified and is someone who is known to the police. Prior to the General Meeting he was seen camping in the Crestwood bushland. Crestwood residents who are walking Continued on page 2

in the area are being asked to pass through the bushland, and if they see someone camping, to report this to the ranger or the police. Being in public open space such as the Crestwood parks, is not an offence, but camping in this area is.

Canning Vale police advised the President there had been four burglaries reported recently, two on Grenadier Drive and two on Regency. Entry was made at one via a security screen door that was only snib-latch locked. It these doors are not key locked, but secured only by the snib latch, it is possible to snip the flyscreen and insert something through the security mesh to move the latch and open the door. If you have a security screen door, this should always be locked with a key.

This last point led to one final question and that was whether security doors should be locked with a key when the family is home. A concern was raised that in case of a fire, the family could be trapped inside. The President responded that these types of doors should be locked, but he emphasised that each family member must know where the key is kept. He suggested that each family work out a fire escape plan.

We are pleased to announce that we have received a number of responses but, as the decision date is still some time off, I am unable to advise who the successful tenderer will likely be.

Aesthetics

- 1. [A residence on Grenadier Drive] You have submitted an application to erect a Colorbond fence on the boundary between your front garden and underpass D. Since the fence borders on an underpass and extends to the road, the Committee requires an open, see-through fence to comply with the fencing policy and to minimise graffiti.
- 2. [A residence on Grenadier Drive] Thank you for your letter regarding the lemon scented gum tree in the park behind your property. The Committee has inspected the tree and finds it to be a young healthy specimen and can see no reason to remove it at this time. The tree also weathered the recent storm without problem. We will monitor the tree as it grows and will remove it if it is deemed to be dangerous.

The Committee also considered your application for building a retaining wall in brick with a tubular steel balustrade. The Committee approves in principal your application, but will require copies of your building licence from The City of Gosnells and engineer's drawings and details for the retaining wall. A significant structure of this type will have to be positioned on the boundary line and a survey will be required to confirm the boundary.

3. [A residence on Princeton Court] Thank you for your application for building approval for the construction of your new patio I confirm that your application has been approved by the Committee. We hope all goes well with your construction.

INCIDENT REPORT

Incidents reported on the Crestwood Estate

The Comment News reported burglaries on Grenadier Dr and Princeton Ct in the 16 February issue.

Canning Vale police advised the President of four burglaries in late February, two on Grenadier Dr and two on Regency Dr.

A car was broken into at 8:30 Saturday morning while parked in the driveway of a Coronet Ct home. This occurred in mid March.

Escape Plans Surviving a house fire

Do you know what to do if fire breaks

out in your home? Many families owe their lives to working smoke alarms.

A home fire can expose you to temperatures in excess of 600 degrees C, however, most people die from inhaling smoke and toxic gasses long before the flames reach them. Families who are well-prepared are more likely to escape their homes safely and without panic. You can't smell smoke when asleep, so smoke alarms are an essential early-warning system to alert you and your family to the dangers of fire and smoke.

Making a home fire escape plan

Gather the family and draw your home floor plan on a grid, marking all the exits. Get the children involved. Ask them to help you identify the two quickest and safest ways to get out of the house from every room, including upper floors. Agree on a place to meet outside and stick to it. The letterbox may be a suitable location.

Once you've prepared your plan, hold regular fire drills and see how quickly family members can get out of the house. It's a good idea to practise at least twice a year - more often if you have young children.

- ... If you have window locks fitted, make sure keys are accessible should they be required
- ... If children's bedrooms are located at the other end of the house, consider how you will be able to reach them if access is blocked by fire. Remember, children may not wake up to the sound of a smoke alarm operating. If your home has a second storey consider how you will exit from upstairs windows. Many hardware stores sell chain ladders for this purpose
- ... If your household includes members who are elderly or disabled or have limited mobility, you will need to make special arrangements in your plan.

Fire survival rules

If your clothes catch fire, stop, drop and roll to smother the flames. To help someone else, throw a woollen blanket over them. If there's smoke in your house, get down low and go, go, go!

- ... In a fire, the safest area for breathing is near the floor where the air is cooler and cleaner, so remember to crawl low in smoke. Check doors for heat before opening.
- ... Use the back of your hand to check for heat, then get down low and crawl to safety. Close doors behind you if possible. If the door is hot, use another exit.
- ... Get everyone out of the house as quickly as possible. Call the fire brigade from a neighbour's house, public or mobile phone and wait for them to arrive. Tell them where the fire is and if anyone is still inside.
- ... Don't go back inside for any reason.

Don't let deadlocks block your escape

Your life could depend on how quickly you are able to get out of your home in the event of a fire. Smoke spreads quickly, cutting visibility and causing disorientation. If you use deadlocks while inside the house, leave the key in it or install a key holder next to the door.

Learn basic first aid

If someone has a burn, stop the burning process. Remove clothing, unless it has stuck to the skin. Cool the burn. Immerse or flood the burnt area in cool running water for 15 to 20 minutes. Never use oil, butter or ointment.

Cover the burn with a clean cloth or cling wrap and keep the patient warm. See a doctor if the burn is blistered, larger than a twenty cent coin or on the face, hands, feet or genitals. Telephone 000 for an ambulance.



Committee Business:

Parks and Reticulation: A quote has been requested for a survey of the area around Underpass D. The water problem at the same underpass has now been sorted, as has the condition of Bore 4 which is now up and running.



The parks are not in optimum condition and Taffy has been asked to come in to fix problems associated with the reticulation system.

A footpath damaged during removal of a tree has been repaired with the cost being borne by the contractor.

Pool: Incorrect chemical levels have been found in the pool. Neil Gannon from the YMCA has visited and advised that changes are to be made to the pool attendants' work schedule to prevent a repeat of the problem. Additionally, a chemical check sheet will now be faxed daily to Neil and Trevor.

The YMCA has quoted for their services for next year's season. A tender notice will be placed in the West Australian with the YMCA invited to officially submit a tender.

Two new gas bottles and 10 new lounges have been purchased for the pool.

Finances: Budget information has been prepared and will be circulated to homeowners before the Special General meeting.

Sandra will approach the City of Gosnells about the repainting of our underpass murals and the possibility of obtaining a grant to help pay for such work.

Social: The inflatable scheduled for the pool on 30 January before the start of the new school term had to be cancelled. It was unavailable for that date.

General Business: Four committee positions are to fall vacant at the next AGM, those of president, aesthetics, pool and treasurer. Residents will be encouraged to apply for these.

February 2010

Committee Business:

Parks and Reticulation: Taffy is currently helping to sort out the reticulation problems. Bore 4 is now fixed and working well. More sprinklers will be required for watering the parks.

Pool: Trevor will meet at the end of the month with the YMCA and officially notify them of the advertisement opening tenders for the next season of the pool. It is felt that the current staff at the pool still require close supervision.

Aesthetics: A prospective buyer has inquired about Crestwood's fencing policy. The water heater has now been removed from the front of a house on Princeton Court. John will also have a word with the of owner of the property on Regency Drive where the lawn has been removed from the garden in front of the house but no replacement plants have been put in its place.

Finance: No grants have been found to date for refurbishment of the underpass murals.

Four homeowners still have outstanding fees to be paid on the their Crestwood rates.

Social: No social activities have been planned

General Business: Sandra is to have a chat with Rod regarding timing of the Crestwood website.

A general discussion touched on young offenders getting into the back yards of properties on the estate and trying to break into houses. Homeowners are asked to be vigilant about this. If you have security screen doors, the recommendation is that these always be keyed and not just latched.


