Recent correspondence from the Committee of the Crestwood Homeowners Association.

To Resident Hume Road

Thank you for your letter 29th January 2015 requesting Crestwood investigate the safety of the large tree in your neighbour's garden in Regency Drive.

The tree you are concerned about is not a local species, it's a Lemon Scented Gum, a Queensland native, and Crestwood would have no objection to its removal. This type of tree is prone to dropping limbs and can be dangerous. As to whether your neighbours insurance would cover any damage would be a matter for the insurance company.

Removal of the tree would be the best option. Trimming or pruning would make the tree more dangerous because the regrowth is unstable. The estimated cost of removal is around \$3000.00.

To Resident Hume Road

Thank you for your letter requesting the removal of a large tree in your back garden. The tree is not a local species. Its a Lemon Scented Gum, native to Queensland. Crestwood Committee has no objection to your removal of this tree, as you have realized already this type of tree does drop limbs and can be dangerous.

T & A Tree Services is well known to Crestwood they do all the lopping and pruning in the parks. If access to the park is required please see Richard the gardener regarding the bond.

Pool Report March - April 2015

The end of the pool season is nearing, and although the weather has remained warm, the temperature of the pool has begun to dip markedly. Correspondingly there has been a marked decline in the number of pool users. Please be aware that with cooler or inclement weather there will be days when the pool closes early or does not open (temperature below 22 degrees).

This season has gone well. Attendances have been comparable with other years, and there were no major problems or disruptions. There have been no major issues with the filter or pumps. There were the now routine repairs to the shade sails. This year 5 have required restitching, and the toddler's pool shade structure had to be replaced before the beginning of the season. The old one collapsed after a stormy night. We also had to replace a section of fencing that was kicked in by some unwelcome visitors one night.

The season will officially close on Sunday April 19. As usual there will be a "busy bee" on the first Sunday after the pool closes, to clean up and pack everything away. This year that will be on Sunday April 26 at 2:00 pm. If you can spare an hour it will help greatly to speed up the task.

I'm already looking forward to next season. As usual I have been ably assisted by Jason and the attendants from Belgravia Leisure. Marjan van Dijk continues to deal with hall bookings and Daphne Bonjanjac has been fantastic in organising the pool passes.

Finally I would like to thank our gardener Rich for his assistance throughout the season.

Parks & Gardens report for Feb/March

- Planted Frangipani in place of the Cocas palms at the pool gate
- Reported to COG damage to park open space consistent to contractors' trucks coming and going through to park 5
- Repaired valve at the entrance gate to Ovens Road, damaged by trucks entering and leaving Estate grounds the day before
- COG repaired wheel ruts caused by sub-contractor
- Pruned Hibiscus at underpass D as it's HEAVILY infected with Mealy bug. Treated with systemic insecticide.
- Herbicide spraying (non- selective) for the control of annual and perennial weeds and grasses situated along footpaths, light poles, garden beds, park trees, retaining walls, fencing and alike throughout the estate parks and underpasses.
- · Herbicide sprayed
 - along the bank of underpass D (prep. for planting).
 - section of Hume road in readiness for planting (second application).

Parks & Reticulation

- · teardrop roundabouts and Council verges along Spencer and Regal Drive fence lines and garden edges
- SPOT sprayed for the control of Parramatta and Paspalum spread through parks 23, 24, 25, 26, 27, 28, 29, 7, 11 and 18. * (patches will occur through these parks which have been sprayed and will remain visible for at least 2 months until other grasses grow over)!
- Seasonal change
- Reduced evaporation levels cooler and shorter days with damp mornings prompt the following...
 - Reduced residential watering to 15 minutes 3 times per week
 - Reduced the park watering to once a week.
- Recommendations for all who enter the estate must apply to the same rule as residents and Crestwood contractors
 who enter the estate to first contact the grounds person prior to entry so that an escort through can be assigned to
 limit damage to the estates assets and infrastructure.
- Note: with seasonal changes and coming rains the parks will soon become saturated and waterlogged, therefore
 the permissible weight of vehicles to enter the estate will be reduced to 5 ton fully loaded unless there is an emergency i.e. fallen tree which may need to be removed.

Parks and Reticulation

- Ad hoc reticulation tests were discussed. As previously, each household tested, simultaneously activated another 7 houses, causing possible inconvenience or hazard.
 - As Rich has worked out how to turn on just one valve at a time, Frazer has requested that he advises any resident requesting a test to give advance notice to their affected neighbour.
- The Committee discussed the Parks, Gardens & Reticulation Budget and Works Forecast.
 - □ It was agreed to go ahead with the Reticulation Capital Works Program.

COMMITTEE MEETING # 511 Monday 23 February 2015

Correspondence

- An acknowledgement letter has been received from Martin Wynn, pastor of Thornlie Baptist, thanking us for the
 donation and reiterating their willingness to be involved in the 2015 Carols.
- Trevor contacted a resident of Grenadier Drive regarding parking of commercial vehicles & trailers within the
 estate to let him know that this issue is not covered by our Deed of Covenant, however he could peruse the City
 of Gosnells' Local Laws via their website.

Reports / Issues Arising

• At the COG Council Meeting held on 10 February the City voted to increase their annual contribution for maintenance of the Estate's public open space to \$110,000 per annum as of next financial year, with a review every 3 years.

General Business

Both Trevor and John gave notice that neither would be standing for re-election in May.

COMMITTEE MEETING # 512 Monday 23 March 2015

Correspondence

- An email has been received from a resident whose property is opposite the pool area regarding anti social behaviour in and around the pool area.
 - Trevor has responded to the email regarding anti social behaviour in and around the pool. Although too late in the season to change the current rules, Trevor believes children's passes worth considering for next year. Darren will also liaise with Belgravia pool staff to ensure such behaviour is monitored and the Police contacted if necessary.

Parks, Gardens & Reticulation

- A resident of Cavalier Court contacted Rich regarding a Eucalyptus Camaldulensis leaning towards his property
 which has also shed a few branches. The resident has concerns for the safety of his children whilst playing in the
 garden and park.
 - Mark Short from COG inspected the tree and advised that branch shedding was an indicative characteristic of the tree but he believed it was healthy, stable and self supporting. Frazer is happy with this advice.

Reticulation

- A decision on the Controller System upgrade that the Committee wishes to have installed, will need to be made soon as there is only a small window of opportunity where it can be installed and the chosen contractors will require sufficient time to gather supplies prior to installation.
 - Frazer advised that the SD Controller system may have pressure issues so he and Rich will be visiting John XXIII College during the week to view the Sentinel system. A decision will be made after this visit along with discussions and quotes from the two suppliers.

General Business

- Roy advised that our Auditor Michael Lee would not be re-nominating for a further one year term.
- Trevor announced that Niki would be resigning as Treasurer because of family commitments, together with part time work, had made it too difficult for her to continue. She plans to remain on the Committee until alternative arrangements are made.
- The AGM notice (plus nomination form) needs to be sent out before our next Committee meeting, so which date is preferred?
 - □ Trevor has advised that the AGM will need to be held on Wednesday 27 May.

Crestwood Hall Hire

The Crestwood Hall is available for use by residents. It is ideal for large or small functions: birthday parties, morning teas, playgroups, meetings. It can be hired on a one-off or regular basis. Charges are as follows.

Daytime (to 5pm) — \$11.00/hour to a maximum of \$55.00 Night-time (to midnight) — \$22.00/hour to a maximum of \$110.00.

Up to 50 people are allowed in the Hall. Full use of the kitchen is included for both day and night functions.

Commercial (for-profit events or those charging an entry fee) — \$25.00 per hour to a maximum of \$100.00 – 8am - 5pm

A \$300 bond applies to all bookings made by homeowners and \$500 to those bookings made by tenants. A minimum cleaning charge of \$150 will be taken from the bond if the hall is not cleaned to a satisfactory standard.

Hall hire does not include access to the pool area. For children's parties there is a minimum adult supervision requirement.
